### **Dave Moulton - Four Corners Sewer Update**

Mr. Orcutt informed the BOSC that an inspector was on site and an issue he found is being addressed.

#### Planning Board Liaison's - Burke & Barringer

Mr. Burke of the Planning Board informed the BOSC that he was surprised by the most recent plan to extend the sewer district to 227 Boston Road. Mr. Burke said they are here today to ask if in the future they can have better communication between the two boards. He told the BOSC the town has a Master Plan and feels both boards should be insync with one another and just would like to be going in the same direction. Mr. Gmeiner asked if they use utilities to control growth and Mr. Burke replied "yes we can". Mr. Barringer said by controlling utility access development can be controlled. Mr. Burke also said when you have sewer, you allow for further development and a lot of communities use Title V to control development.

Mr. Orcutt suggested that the board should look into adopting a policy for any requests to extend the sewer district. He recommended advertising in the local paper for two weeks and to hold a public

hearing, he also added that if someone wants more than one thousand gallons of capacity, there should be a public hearing.

Mr. Barringer mentioned the density of housing in West Groton and if they put in a sewer connection in, it would have changed the whole character of the area. He feels that the town has recognized sewer as a development tool. Mr. Gmeiner asked what else besides having a public hearing can be done. Mr. Burke replied that some states have more advanced planning, designated in the urban areas; he suggested that better communication between the boards and that the Planning Board can assist the BOSC with the master planning. Mr. Burke also stated that the Planning Board would love the BOSC involvement so there is better synchronization when planning. Mr. Bouchard then asked what if there is available capacity and Mr. Gmeiner said that if it's in the District and we have available capacity we do not have control. Mr. Burke informed the BOSC that expansion of the District is their main concern.
