Filho's Grease Trap

Mr. Gmeiner told the BOSC after reviewing the photo's provided be Pepperell it looks the first section was clear, then when they reached 136.6, they could not proceed thru with the camera inspection, due to grease. Mr. Gmeiner told the BOSC that he feels the grease trap for the restaurant could be undersized. He asked that Ms. Livezey reach out to Mr. Grossman/BOH and find out what questions we should be asking to determine the proper size grease trap. Mr. Orcutt told the BOSC that the upper section is cleaned on an annual basis and that the lower end never has been cleaned and that this is the first time that Pepperell has decided to clean all the way.

Mr. Orcutt told the BOSC that under the new guidelines for a new DOT permit, the contractor needs to fill out the necessary paperwork for the DOT and apply for a trench permit then submit to the town. After that Mr. Orcutt can sign and submit to the State. Mr. Rafferty submitted a permit and the new rule is that it cannot be submitted without a trench permit. Mr. Bouchard asked if there was a trench involved in this project and Mr. Orcutt replied that there is an access hole and they have to dig a small area. Mr. Bouchard

also asked if we still need a certified contractor and Mr. Orcutt replied yes and that the owners of the property provided him with a list, but he is unsure of the drillers at this time.

Chapter 396 Review and Organization

Mr. Bouchard submitted a proposal to the BOSC for Chapter 396 and adding a new Chapter 397. Chapter 396 would be for the Center Sewer District and Chapter 397 would be for the Four Corners Sewer District. He suggested we add Groton Sewer Commission to the town's web site to access. The BOSC was in agreement and Mr. Bouchard said he would continue working on this.
