The Meeting was called to order by James Gmeiner at 3:00 P.M.

#### 18 Breakneck Road - Sewer Connection

Mr. Aiken told the BOSC that he has reviewed the sewer connection guidelines and is looking to extend the district to 18 Breakneck Road. Mr. Gmeiner said he saw an inquiry stating the distance to be 500' and he believes it would be more like 1,000'. He also told Mr. Aiken the following would be required:

- 1. Town Meeting vote to extend the district
- 2. All costs involved construction, engineering and inspection fees would be the applicant's responsibility
- 3. Connection fee for a 3-bedroom would be \$6,000.00.

Mr. Bouchard also added that a public hearing would be required and notification to all abutters. Mr. Aiken asked if the notification to all abutters would be needed before getting on the warrant for town meeting. Mr. Gmeiner told Mr. Aiken the BOSC could submit a placeholder for the warrant

Mr. Gmeiner extending the line down there he would be passing by four houses and another parcel front on Longley and suggested that the applicant reach out to them and see if they want to connect. Mr. Boucher asked about the abutters list and which ones would need to be notified and Mr. Gmeiner replied "our policy requires all the abutters be notified"

Mr. Gmeiner asked if a septic design was approved and Mr. Boucher said Mr. Grossman denied it. Mr. Aiken also said the soil was not ideal for septic. Mr. Boucher asked if direction drilling would be required since it's a newly paved road. Mr. Gmeiner said he is fine with directional drilling and that Mr. Delaney would not want a newly paved road being dug up. Mr. Gmeiner replied the line would be considered a gravity line and a grinder pump would be needed.

Mr. Gmeiner told Mr. Aiken we can discuss the capacity and the current system at the public hearing. Mr. Boucher asked if the public hearing would be held before town meeting. Mr. Gmeiner replied that all the abutters need to be

notified by certified mail by Mr. Aiken and we will advertise for the public hearing and Mr. Aiken would be invoiced for the cost of the advertisement.

Mr. Bouchard asked what the plan was for the property and Mr. Aiken said he hopes to do (4) units because doing one would not be cost effective. Mr. Gmeiner did add that if this was approved at town meeting there is a mandatory bylaw that once accepted into the district the connection has to be made. Mr. Aiken asked if the septic was approved in the meantime, the would be forced to connect to town sewer. Mr. Gmeiner replied "yes or be voted out of the district". Mr. Bouchard suggested that Mr. Aiken have a more concrete plan before considered being voted in the district. Mr. Gmeiner said it would be good to nail down the project so we could determine the amount of capacity needed. Mr. Bouchard mentioned that there would be a connection fee/per dwelling unit on the property. Mr. Boucher asked if (4) units would this be considered (4) connection fees. Mr. Gmeiner said "yes" assuming they are no more than 3-bedrooms each. Mr. Aiken asked what would 4-bedrooms be and Mr. Gmeiner replied that is basically is \$2K per bed, with 3-Bedroom minimum.

#### 436 Main Street

Ms. Crory told the BOSC that Mr. Haddad signed the notice to award and it was sent to Mr. Rafferty. Mr. Gmeiner asked if the bid awarded was \$25K and Ms. Crory replied "Yes".

Mr. Gmeiner said there is nothing to report, but he did send Mr. Haddad an email and he agreed to draft the sewer easement and get us a copy.

Mr. Gmeiner asked Ms. Livezey to send a memo to Ayer requesting that this be billed in October.
