# 108 Pleasant Street - Sewer Connection Meeting started with this

Mr. Gmeiner said he has received the revised plan and suggested that we have the engineer review the elevations before we start. Mr. Collins agreed and that Mr. Lagasse is doing the work and he is familiar with the system. Mr. Gmeiner told Mr. Collins that there will be inspection fees and engineer fees associated with the project and Mr. Collins said Ms. Bryan is aware of this. Mr. Gmeiner said the connection fee for the Carriage house would be one fee of \$6,000.00 and the main house would be  $5/3 \times 6,000.00 = 10,000.00$  so the total would be \$16,000.00 total. Mr. Collins said its 7 bedrooms and all that can occur on that site because house on individual parcel and there is a conservation restriction on the rest and was presented at town meeting that way.

Mr. Collins said he would provide an as built when complete.

Mr. Gmeiner said the stretch to the manhole to property may be an issue. Mr. Collins said from the house to the carriage house there is a manhole where this is headed and would be installed and that would be a private and once enters in street would be yours, if others wanted to connect if need be. Mr. Gmeiner replied "yes" and that is why we want to have inspected, so we know what we are getting and it would be in good working order. Mr. Collins said he explained to Ms. Bryan we would need a road opening and he would speak to Mr. Haddad and Mr. Delaney. Mr. Orcutt suggested he call Mr. Delaney for the road opening permit.

#### 436 Main Street

Ms. Crory said there have been a few more inquires regarding bidding on the project. Mr. Gmeiner told the BOSC that he has visited the conductor lab committee to let them know we are working on it. Mr. Bouchard asked if any bids have been submitted and Ms. Crory relied "only inquiries".

### 546 Main Street - Capacity Charges

Mr. Orcutt told the BOSC that this property is being torn down and will be developed as a Temple. He said he has not seen any plans yet.
